PRICES OF PRODUCTS SOLD

The prices listed in the relevant catalogs under each product are VAT- inclusive, while NEW CUST S.A. reserves the right to adjust its catalog prices.

WITHDRAWAL – PRODUCT RETURNS

The products sold by NEW CUST S.A. fall under the category of perishable goods and, according to the Law no 2144/2013, article 3b on consumer rights, they are excluded from the consumer's right to withdrawal. Therefore, for reasons concerning the protection of public health, NEW CUST S.A. cannot accept the return of products it markets through its website. However, NEW CUST S.A.

may refund the purchase amount for any products delivered that are proven defective due to its own negligence.
