Which personal data we collect about you

Who we share your data with

We may pass on your personal data, that we collect during your visit to our website, to third parties (e.g. Security and Public Order Services, Public Authorities/Services acting as part of a judicial process or pursuant to a public prosecutor's order), in case this is necessary for us to fulfill our obligations arising from statutory provisions.

Protection of minors

In the event that minor users voluntarily visit our website and to the extent this cannot be controlled, the company bears no responsibility.

Your rights regarding your data collected by the Site

We inform you that you have the right to:

Access your data,

Rectify your data in case of inaccuracy,

Erase your data in specific cases,

Restrict the processing of your data, in case certain conditions apply

Object to the processing of your data, in case certain conditions apply



The portability of your personal data,
File a complaint with the Hellenic Data Protection Authority in the event of an unfortunate incident of a breach of your data.
The company will examine and respond to your above requests within one month of their receipt. Exceptionally, this deadline can be extended by 2 more months, in case more time is required and the request is particularly complex.

Protection measures we have applied

We have applied appropriate security measures aiming to prevent any accidental loss of your personal information or the use or access of your personal data by unauthorized users.

Those who process your personal data for the lawful purposes explained above are subject to a strict duty of confidentiality.

Supervisory Authority
